Discussed possible repercussions going forward if land is already in use as a garden. Whether this gives any automatic rights to build. Cllr Larcombe to check this out.

OBJECT Has there been a change of use application.

It was decided that this development of a garden could herald an undesirable situation, whereby many ancillary items could be brought on to the plot, such as sheds and buildings, play equipment, furniture, garden items, machineary & equipment etc. All of the above could be could be done under permitted development. The owner has chosen to erect an approx. 6' close boarded fence around the property. Property appears to be outside the settlement boundary.
