This is very concerning as no work should be carried out on site prior to planning permission being granted and it also forms part of the bat roost included in the Ecology Report which is recommending REFUSAL. It was agreed that Liz would keep a watching brief as she lives close to the site and Cllr Larcombe would alert TVBC.

Concern was raised about the clearing of the copse on The Observatory land adjacent to TVF and how this might affect the bat roost. Liz was told by the site workmen that they had done an Ecology Report but Cllr Ewer is going to speak to CEO at The Observatory.
